Recognizing Clinical Indicators for BULLET-PROOF CODING

No matter how well a provider follows an evidence-based definition in diagnosing and documenting a patient's condition, and no matter how well a coder follows the conventions outlined in the ICD-10-CM Official Guidelines for Coding and Reporting and official advice published in Coding Clinic ... auditors often insert their own interpretation of disease definitions and supporting clinical indicators to declare that an ICD-10 code based on your documentation is clinically invalid and can be removed or denied.

It is up to *you* to recognize clinical indicators to ensure bullet-proof coding.
